Private charging station for electrical vehicles	25% of the amount of the state premium with a maximum of €200

The conditions for the grant state as follows:

Documents to be attached:

1. Certification of the state premium premium indicating the amounts and specific features of the grants awarded
2. Paid invoice for the purchase of a new cycle
3. In the case of a second-hand cycle a bill of sale and a photograph of the bicycle, showing the purchased cycle, the date of purchase and the amount paid
4. In the case of a second-hand cycle, the full name of the person receiving the cycle.

Only one grant is awarded per person over a 3-year period.

The grant is subject to repayment if it was obtained as a result of false declarations or inaccurate information.

Grants are awarded for acquisitions made and equipment installed as from 1st January 2025.

The municipal administration reserves the right to request any additional documentation if it deems it necessary in order to verify the compliance with the conditions for the grant.

Applications must be submitted to the municipal administration within six months of receiving confirmation that a state grant has been awarded for the facilities and equipment in question, or of the purchase of the second-hand item.

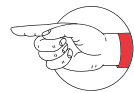
