

Holiday activities 2025

Spillnomëtteger

Holiday activities will be running from 16th July 2024 to 30th July 2025.

The deadline for registration is 15th May 2025.
Any requests received after this date will not be accepted.

The hourly rate of financial assistance available to families is calculated based on the **chèque-service rates**, established by the Ministry of Education, Children and Youth.

How to benefit from the reduced rates:

In order to benefit from the reduced rates, it is essential to register for chèques-services. Invoices are sent monthly by the S.I.G.I. (Syndicat Intercommunal de Gestion Informatique).

You can sign your child(ren) up for as many days you wish.

Children who are not registered for chèques-services pay the maximum rate (i.e. 7.50€ per hour) at the Maison Relais. Contracts must be renewed annually.

More information on chèques-services can be found on the last page of this magazine.

Please take note of the following:

- Children who are signed up at the Maison Relais from 16th July 2024 to 30th July 2025 are automatically signed up for the holiday activities (you do not need to hand in the registration form for the "Spillnomëtteger").
- The Maison Relais will be closed from 4th to 15th August 2025 inclusive.

Description:

The theatre project consists of several workshops held over a period of two weeks at the Maison Relais in Steinfort and is open to all children participating in the holiday activities of the municipality of Steinfort.

During the first session, the children take part in a story development session where they can actively participate in the creation of the plot of their "play". The supervisors then organise the story and divide it into different sequences. The children are then divided into working groups. Each group is given a specific task, be it designing the set, costumes, music, communication, acting, sound, etc.

During the following two weeks, the groups work on the realisation of their tasks. The aim is to perform a play developed by the children themselves on Wednesday 30 July 2025 in the cultural centre 'Keeseminnen'.

Workshop Duration:

From Wednesday, 16 July 2025, to Wednesday, 30 July 2025, from 2:00 pm to 5:00 pm at the Keeseminnen cultural center.

Protection of personal data

Information collected in the present form is necessary in the context of your "Application for registration of your child for holiday activities at the Maison Relais in Steinfort". This personal information will be the subject of computerised treatment which is necessary for the processing of your request. The only recipient of the information and personal data of the child, of the legal guardians, of the persons authorised to take back the child (other than the legal guardians) and of the medical information concerning the child is the Commune of Steinfort and the Maison Relais in Steinfort, as well as, after introduction of these personal data in the PGI programme of the SIGI (Syndicat Intercommunal de Gestion Informatique) and the Chèque-Service-Accueil programme, the Ministry of Education. They are registered in the computer system of the Commune and the Maison Relais, as well as in the PGI programme of the SIGI (Syndicat Intercommunal de Gestion Informatique) and in the Chèque-Service-Accueil programme of the Ministry of Education. Your data, the data of the persons authorised to take over your child and your child's data, as well as the documents to be attached to the application, are kept at the Commune for the time necessary to fulfil the purposes mentioned above and at the Maison Relais for the duration of your child's enrolment at the Maison Relais in Steinfort or for as long as the legislation requires us to keep them.


In accordance with Regulation (EU) 2016/679 on the protection of individuals about the processing of personal data and on the free movement of such data, you have the right to request from the controller access to, rectification or erasure of, or restriction of the processing of your data held about you and your child. You have the right to object to the processing of your data, the right to have your data deleted and the right to challenge a decision taken based on automated processes. In addition, you have the right to lodge a complaint with the Commission nationale de la protection des données (CNPD) if you consider that the processing of your data is not in accordance with the law.

What is a chèque-service accueil?

(childcare service vouchers)

The chèque-service accueil (CSA) came into force on 1st March 2009. It is implemented by the Ministry of Family Affairs and Integration together with the municipalities. It is intended for **children** who are members of the childcare-service voucher scheme, who are under 12 years of age, and who have not left basic education.

The CSA is a benefit in kind that gives parents **reduced rates for education and childcare services in the field of non-formal education, depending on the availability of places.**

The amount of the state contribution (amount of the CSA) and the amount of the parents' financial contribution are calculated on a case-by-case basis considering the income situation, the number of children in the household receiving child benefits and the number of hours of non-formal education during which the child is cared for.

Direct beneficiaries of the chèque-service accueil are all children who meet the following conditions:

- Resident in a Luxembourg municipality
- Since September 2016, non-resident workers can join the CSA and benefit from the offer of CSA providers in Luxembourg. For more information, please contact the "Zukunftskees".
- They are aged between 0 and 12 years and/or have not left basic education.

Children at risk of poverty and at risk of social exclusion are privileged beneficiaries of the CSA. In these cases, parents are asked to report to the

The targeted educational childcare is offered by various providers across our country:

- Holiday camps and activities.
- The multilingual education programme has been in place since January 2018. The aim of this programme is to familiarise children in the crèche with Luxembourgish and French to give them the best possible start in life and at school.



L'ÉDUCATION NON FORMELLE GRATUITE POUR VOTRE ENFANT

Un pas de plus vers l'égalité des chances

L'éducation non formelle (maisons relais, assistants parentaux, ...) joue un rôle essentiel dans l'épanouissement de votre enfant et pour ses chances de réussite. Elle complète l'éducation formelle dispensée à l'école. Elle permet à votre enfant de développer, dans une ambiance décontractée, les compétences essentielles : langage, motricité, relations sociales, créativité, aptitudes techniques, participation active.

C'est pourquoi l'éducation non formelle devient encore davantage accessible. Si votre enfant fréquente déjà une structure d'éducation et d'accueil, veuillez simplement vérifier que votre contrat est en cours de validité, car son renouvellement ne se fait pas automatiquement.

Si ce n'est pas encore le cas, vous devez d'abord adhérer au système du chèque-service accueil (CSA). Pour adhérer au CSA, rendez vous dans votre commune, si vous habitez au Luxembourg. Si vous êtes frontalier, adressez-vous à la <u>Caisse pour l'avenir des enfants</u>.

Les repas sont-ils aussi gratuits?

Pendant les semaines d'école, les repas de midi sont aussi gratuits pour tous les enfants soumis à l'obligation scolaire. Pendant les vacances, la gratuité des repas est réservée aux familles disposant d'un revenu inférieur à deux fois le salaire social minimum. Pour les autres familles, c'est le <u>barème</u> du CSA qui s'applique.
